2. Emergency Filing Activation Fee	\$5,000	Required to activate the attorney to immediately file in federal court and manage the initial legal work. (Must be paid via credit card within 1 hour of detention.)

Potential Fee Recovery: In successful cases, attorneys' fees may be recoverable under the Equal Access to Justice Act (EAJA).

ICE Check-In Attorney Representation

Scope of Service: Legal Support and Advocacy

This flat-fee service covers complete preparation and on-site representation for one scheduled ICE check-in appointment.

Component	Detail	
G-28 Preparation	Formally file the G-28 (Notice of Entry of Appearance) to establish attorney representation before ICE.	
Attorney Attendance	An experienced attorney will accompany the client to the scheduled check-in.	
Time Allotment	Covers up to four (4) hours of attorney time on that single day of the check-in.	
Advocacy	Attorney will speak with ICE representatives and advocate for the client in person, via phone, or video.	

Scope Limitation and Billing

This service is strictly limited to the preparatory work and attendance of one scheduled ICE check-in.

- Additional Time: Any attorney time spent beyond the initial 4 hours on the day of the check-in is billed separately at \$400 per
 hour.
- Outside Work: Any other required or optional legal work (e.g., motions, appeals, subsequent hearings) is outside this scope and requires additional payment.

A single flat fee secures the necessary preparation and the attorney's dedicated time at your scheduled appointment.
